Questions

- Q1. Is FIT a public or private institution for this project?
- A1. FIT is a public institution.
- Q2. RB-02 as shown in Detail 15 on Drawing A-201.00. Is RB-02 Base in 2nd floor Lobby part of Base Bid or Alternate #1 (I am thinking Base Bid)?
- A2. All of A.201 is part of the add alternate. Please refer to the definition in the alternates section of the project manual for more information.
- Q3. Please see the following Concern we received from one of our vendors concerning Addendum 4.

The items Tagged in the Accessory Schedule AC-01, etc., do not match the items shown on A.201, A.202 where they're tagged such as BCS, TTD, SCD, etc.

Not that big of a problem for most I can figure it out, but there are missing items such as WR-Waste Receptacle shown on plans but not in the Addn 4 AC schedule.

They should really revise the plans to match the schedule items or revise the schedule to match the plan items.

- A3. Refer to finish schedule on A-900 for bathroom accessory tagged on the associated enlarged plans. A-201 has a diagram of typical dimension plans for each item and abbreviations are used. BCS, TTD, SCD are abbreviations, not keys.
- Q4. We just received the following RFI from one of our specialties vendors. We need to provide the model number for the accessories for proper pricing.

SUNY – FITNYC Haft Theater Bathroom Accessories. The Finish schedule shown on Draw A900 list the manufactures, but there is no model # listed. This is the same with specification section 102800, that refers back to drawing A 201.00, A202 & A900, also does not list any models numbers.

A4. The model numbers were provided in addendum # 4.
