- 2) The question and answer period have passed. No more questions will be accepted.

Questions:

- Q1. The contract has a specification for "Applied fireproofing", but the drawings do not show any work. please clarify.
- A1. Fireproofing is not required on this project.
- Q2. Please be advised that drawing not to scale. Scale given on drawing does not work with on screen. Please verify it.
- A2. Every drawing is to scale. However, refer to sheet G-002, General Notes #2: DO NOT SCALE DRAWINGS; DIMENSIONS SHOWN GOVERN. LARGER SCALE DRAWINGS SHALL GOVERN OVER SMALLER SCALE. USE DIMENSIONS ONLY. ALL DIMENSIONS AND CONDITIONS SHOWN AND ASSUMED ON THE DRAWINGS MUST BE VERIFIED AT THE SITE BY THE CONTRACTOR BEFORE ORDERING ANY MATERIAL OR DOING ANY WORK. ANY DISCREPANCIES IN THE DRAWINGS AND SPECIFICATIONS SHALL BE REPORTED TO THE ARCHITECT. NO CHANGE IN DRAWINGS OR SPECIFICATIONS IS PERMISSIBLE WITHOUT THE WRITTEN CONSENT OF THE ARCHITECT/ENGINEER. NO WORK SHALL PROCEED UNTIL SUCH DISCREPANCY HAS BEEN RECTIFIED.
- Q3. Regarding the answer to Q1 in Addendum No. 2, the quantification of hazardous materials to be removed shall be based upon visual observations from the pre-bid meeting. We respectfully requesting the removals of hazardous materials to be an allowance, which will render all bidders on the same footing through the bidding process for this project.
- A3. There will not be an allowance to the removal of hazardous materials. The cost to remove the hazardous materials must be built into the bid price that you're submitting.

Revisions and Clarifications

- GC to provide temporary construction partitions, poly barriers and temporary doors as indicated in the attached drawings DM-100.SK1, DM-101.SK1 and DM-102.SK1. Temporary partitions and doors to be adjusted as needed during the construction period. Installation to be coordinated in the field. Location of partitions and doors to be reviewed and approved by FIT, CM and the Architect, prior to installation.
