- 2) Please find the two revised drawings A-300 and A-400 (attached below), indicating the changes to the RCP and the elevation.

Questions:

- Q1. Bid drawing "E-600", depicts two panel schedules. Panel LP-D4C is shown as existing & Panel DB-4A is shown as new. However, there is no feeder shown to power up the new DB-4A panel. Please provide feeder plan to power up the new DB-4A panel.
- A1. The panelboard DB-4A and its associated feeder are work that will be completed under a separate contract.
- Q2. In reviewing Addendum #2 responses, with the elimination of VAV-4-3 from the GC scope, a few further scope clarifications are required. The M-104.00 indicates the location of where the GC would connect the new 24"x20" ductwork. Who's responsible for other mechanical scope, left of the connection?
- A2. The other work is part of a separate contract.
- Q3. Who is responsible for the removal and reinstalling of the ceiling tiles in classroom D446, due to the work with the VAV?
- A3. The connection to the ductwork is located in the corridor. The transfer grille and the fire dampers located on the D446 wall is part of this contract. Include in this contract: the ceiling tiles shall be removed and reinstalled as needed for the installation of the transfer grilles and fire dampers.
- Q4. Who is responsible for the fire dampers in the partition demising D446 & adjacent corridor? This would include patching of the walls due to the damper work. Dampers (34'x20", 24"x20", 60"x15")
- A4. Include in this contract all the work asked above in Q4.




