**Work Hours/Shorter Hours During Recess Periods - Full-time Bargaining Employees Only**

Full-time bargaining employees shall work 35 hours per week during recess periods unless they are eligible, as noted in the CBA §43.2, to work 30 hours per week (shorter hours). Full-time bargaining staff becomes eligible for shorter hours during recess periods "on the first day of the fiscal year (July 1) after completion of five (5) years of full-time service".

- **Spring:** Monday, 3/22/27, through and including Sunday, 3/28/27
- **Summer:** Information on the summer 2027 work schedule and Friday college closures will be communicated in April 2027.
